| Course Description                 | The European Union: Economics, Politics and Society The objective of the course will be to introduce students, through the lens of economics, politics and sociology, to the development of the EU, its membership, its political and sociological underpinnings, its key economics policies and its main political organisations and structure. It will cover the economic theory behind the single market, customs union and Euro currency union. It will discuss the raison d'etre of the EU, its growth in membership and functions, the advantages it provides for its members and the difficulties and problems that exist between its member nations from time to time, to include the rise of populism and nationalism (with specific reference to Brexit) threatening its internal unity. In short, the course will provide students with a comprehensive social scientific understanding of the structure, workings and dynamics of one of the world's most significant and unusual of international organisations and examine the extent to which the EU can survive and prosper in the years ahead.   |  |
| Course Syllabus                    | The syllabus of the course will cover the following key topics: 1. The History of the EU, its growth and development from its initial beginnings as the European Coal and Steel Community in 1951, comprising merely 6 members, through to today's union of 27 members which is, by population and national income, one of the largest economic blocs in the world, 2. Political institutions, to include the European Parliament, Council of Ministers, European Commission and Court of Justice. The course will examine methods of decision making in the EU, 3. Key economic issues and policies to include the Single Market and Customs Union, the Common Agricultural Policy, Competition policy and Regional policy. It will examine the underlying economic theory of free trade as the rationale for the Single Market and Customs Union, 4. The European Currency Area. The course will examine the creation of the Eurozone amongst 19 of the members of the EU which binds them in a single currency, and will discuss the advantages and disadvantages of so doing, and the reasons why 8 members of the EU have, so far, remained outside the Eurozone, 4. Key sociological issues to include questions of equality and diversity, environmental problems, migration within and from outside the EU, the refugee question, the rise of populism and nationalism, all of which have led to considerable and ongoing controversy between member countries and caused significant political problems. The particular question of Brexit will be examined. Why did the UK want to leave the EU and what will be the consequences for both the UK and the EU? 5. The future of the EU. Will the EU grow in membership and, if so, which countries will join? Can the EU continue to survive and prosper into the future or will new problems and tensions emerge? |  |
